The Extra Course Fee for the Doctor of Business Administration Programme and the Executive Master of Business Administration Programme is charged based on the number of credits of the respective course(s). Please refer to Item 5 for the fee per credit. In addition, tuition fees do not cover the expenses incurred during field trips. Students are responsible for their own transportation, accommodation, and living expenses during the field trips.
8. Students who participate in outbound exchange or study abroad programmes are required to pay tuition fees to the University of Macau unless otherwise specified.
9. The specific payment schedule is subject to the notice issued by the Finance Office.
